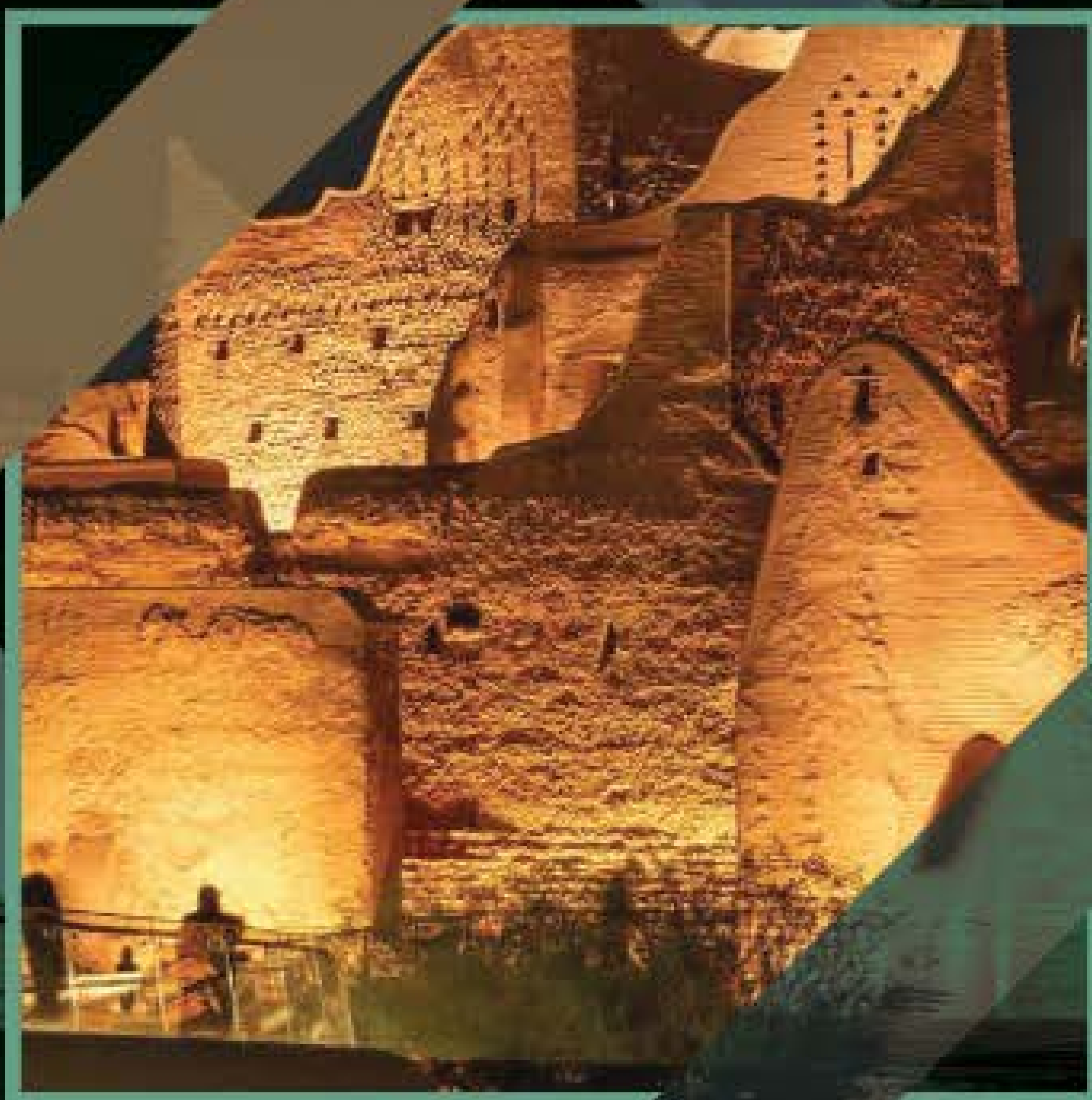

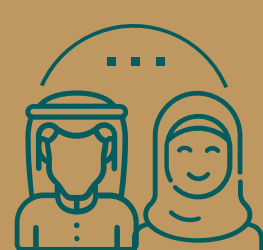

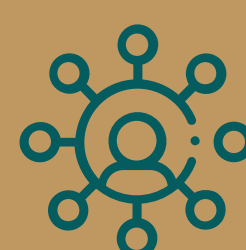

## Eligibility Criteria ♦♦♦

**01** For professionals specialised in healthcare, science and research

**Professionals specialised in healthcare and science**

- Minimum Monthly salary of SAR 35,000

**Researchers**

- Minimum Monthly salary of SAR 14,000

- Employment contract in Approved entities with priority specializations
- Bachelor's degree or higher
- More than three years of work experience in the related priority specializations
- Endorsement letter from the employer

**02** For Executives

- Employment contract for executive level, with a total minimum monthly salary of SAR 80,000
- Endorsement letter from the employer

## Residency Duration ◆◆◆

► Upon issuance:

- **5-years Residency**

► Upon renewal:

- **Renewable for one additional term, subject to meeting product eligibility criteria**
- **Permanent Residency**
  - Maintaining product eligibility criteria
  - Completing a residency of 30 months within a period of 5 consecutive or non-consecutive years

## Special Benefits Premium Residency ◆◆◆

- Eligibility for permanent residency is granted upon meeting specified conditions
- Exemption of the primary Premium Residency holder from the (Nitaqat) Program

**SAR 4,000**





### Eligibility Criteria ♦♦♦

#### 01 First Category

- Nomination or receiving one of the specified exceptional awards Approved by the Ministry of Culture and Ministry of Sports

#### 02 Second Category

- Fulfilling the minimum eligibility criteria approved by the Ministry of Culture and Ministry of Sports.

- Meeting the minimum financial solvency requirement (ensuring the ability to bear the cost of living in Saudi)
- Obtaining an endorsement from either the Ministry of Culture or the Ministry of Sports, depending on the applicant's field

### Residency Duration ♦♦♦

#### ► Upon issuance:

- A fixed term residency for five years.

#### ► Upon renewal:

- A fixed term residency for five years, renewable once upon meeting the eligibility criteria for the product and having a residence for a period of 30 months during five years either consecutive or non-consecutive.
- Permanent residency
  - When continuously meeting the eligibility criteria for the product
  - Having a residence for a period of 30 months during five years either consecutive or non-consecutive
  - Receiving an endorsement to have a permanent residency from the Ministry of Culture or Ministry of Sports or the Ministry of Culture as a prerequisite for obtaining permanent residency

### Special Benefits of the “Gifted” Residency ♦♦♦

- Obtain permanent residency upon meeting the conditions
- Exemption of the primary Premium Residency holder from the “Nitaqat” Program

**SAR 4,000**





### Eligibility Criteria ◆◆◆

- Issuing an investment license
- Providing commercial register and articles of incorporation
- Investing a minimum of SAR 7 million in economic activities in Saudi in accordance with the Investment Law

### Residency Duration ♦♦♦

- ▶ • Direct permanent residency conditioned on:
  1. Injecting SAR 7 million during the first two years
  2. Creating 10 jobs during the first two years

### Special Benefits of the “Investor” Residency ♦♦♦

- Directly obtaining permanent residency

▶ One time fee only:

**SAR 4,000**

## 4. Entrepreneur Residency

### Eligibility Criteria ◆◆◆

#### 01 First Category

- Obtain a minimum of SAR 400,000 round/s as investment from an entity accredited by the center
- The applicant's share in start-up must be at least 20%

#### 02 Second Category

- Obtain a minimum of 15 Million SAR round/s as investment from an entity accredited by the center
- The applicant's share in the start-up must be at least 10%

- Holding an entrepreneur license from the Ministry of Investment
- Providing an Endorsement letter from the investment entity

### Residency Duration ♦♦♦

#### 01 First Category

- A fixed-term residency for five years, renewable for one additional term, subject to continuous meeting of the eligibility standards of the 1st Category and maintaining a residency for a total of 30 months within a span of 5 years

#### 02 Second Category

- Permanent residency directly, conditioned on creating at least 10 jobs in the first year and at least 10 jobs in the second year

### Special Benefits of the “Entrepreneur” Residency ♦♦♦

- Nominate two staff members to obtain the “Special Talent” Residency
- The entity is exempted from ‘Nitaqat’ for the first 3 operational years
- 2nd category: Directly obtain permanent residency

fee only:

**SAR 4,000**





### Eligibility Criteria ◆◆◆

1. Own a real estate assets worth a minimum of SAR 4,000,000 within Saudi
2. The property must be free from existing and future mortgages
3. Property ownership or utilization must not be associated with real estate financing
4. The real estate must be residential
5. The real estate must be developed and not from undeveloped or unimproved lands
6. The real estate asset must be appraised by accredited valuers within the Saudi Authority for Accredited Valuers “Taqeem”

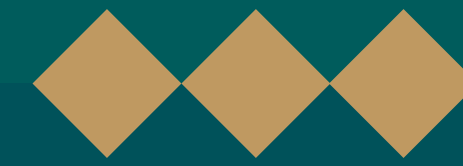
